1. **Additional Labour (loading/unloading):** Charges are per man hour, minimum of 4 hours each.
 - Weekdays: \$62.30 per man hour
 - Saturdays: \$84.10 per man hour
 - Sundays & Holidays: \$84.10 per man hour

2. **Appointment/Notification:** Applies when a specific date/time of delivery or notification prior to delivery is requested. Applies on shipments weighing 0-39,999 lbs only. Shipments weighing 40,000 lbs or more are excluded.
 - \$37.34

3. **After Hours Pickup or Delivery:** Between 6 PM and 6 AM. Applicable to the terminal locations, points outside these terminal locations will be subject to additional charges.
 - \$155.77 minimum within metro areas
 - \$311.47 minimum beyond metro areas

4. **Bill of Lading Changes — Payment Terms, C.O.D., Cancellation, Shipping Weight:**
 - \$7.16 per change
 - \$27.73 minimum

5. **Border Clearance/Security Fees (U.S.-Canada):** Charges calculated on the billed weight of the shipment. Charges are billed in U.S. dollars.
 - \$0.88 per cwt
 - \$23.68 minimum / \$79.19 maximum

6. **C.O.D. (Collect on Delivery):**
 - 6% of C.O.D. amount
 - \$62.30 minimum

7. **Dangerous Goods:** Charges are calculated on the actual weight of the dangerous goods shipment.
 - LTL shipments (0-9,999 lbs) — \$43.58 per shipment
 - TL shipments (10,000 lbs or more) — \$62.91 per shipment

8. **Documents (Proof of Delivery, Bill of Lading copies):** This charge will apply when a copy of the document is requested and an electronic copy of the document is available through request on our web site (midlandtransport.com)
 - \$18.70 per copy

9. **En Route Stop-offs & Offline Mileage:** Offline mileage determined by taking total miles travelled minus the direct miles from origin to final destination.
 - \$109.02 each + offline mileage of \$3.08 per mile

10. **Heated Service:** Available October 15th to April 15th. Charges are calculated on the billed weight of the shipment.
 - LTL shipments (0-9,999 lbs) — 18% of freight charges, \$37.34 minimum
 - TL shipments (10,000 lbs or more) — 18% of freight charges, \$74.76 minimum

11. **In Bond Shipments:** Charges calculated on the billed weight of the shipment, and are in addition to border security fee.
 - \$8.48 per cwt
 - \$102.55 minimum / \$320.79 maximum

12. **Limited Access Locations - P/U or Delivery, including but not limited to: Mines, Construction sites, Government installations, nuclear plants, Schools, etc:** Will be calculated on the billed weight.
 - \$3.42 per cwt
 - \$62.30 minimum / \$124.59 maximum

- 12A. **Residential area or zone, inside and/or hydraulic liftgate pickup or delivery:** Will be calculated on the billed weight.
 - \$3.42 per cwt
 - \$62.30 minimum / \$124.59 maximum

13. **Lumpers, Sortation, Cross Dock fees:** Charges calculated on the billed weight of the shipment
 - \$1.44 per cwt
 - \$43.58 minimum / \$174.41 maximum

14. **Redelivery, Reconsignment, Relinquishment, Diversion:** Charges are calculated on the billed weight of the shipment.
- Name Only - \$27.61
 - Within the designated terminal's service area - \$3.76 per cwt | \$62.30 minimum / \$249.18 maximum
 - Outside the designated terminal's service area - \$27.61 minimum + applicable linehaul charge from original destination to new destination
15. **Reports:** No charge for standard reports available on our website midlandtransport.com.

16. **Storage:** Charges calculated on the billed weight of the shipment.
- DRY — \$1.57 per cwt per day | \$37.34 minimum per day | \$87.23 maximum per day
 - HEAT — \$2.48 per cwt per day | \$62.30 minimum per day | \$201.84 maximum per day
 - REEFER — \$2.48 per cwt per day | \$62.30 minimum per day | \$236.70 maximum per day
17. **Tradeshows:** Midland Customers only; to Atlantic Canada only.
- \$3.42 per cwt
 - \$62.30 minimum
 - \$124.59 maximum
18. **Trailer Detention:** Apply when the trailer is detained by consignor/consignee beyond agreed loading/unloading schedule.
- DRY — \$118.36 per day
 - HEAT — \$201.84 per day
 - REEFER — \$236.70 per day
19. **Valuation Fee:** When the Bill of Lading indicates the consignor requires Midland to accept liabilities up to a stated declared value, an excess valuation charge of 5% (five percent) of the total declared value in excess of \$2.00 per pound on the actual weight of the shipment will be assessed, subject to a minimum charge of \$2.00 per shipment. Declared Valuation is applicable only to new goods. Used goods will move at shippers risk only and are not insurable through Midland.
20. **Waiting Time:** Apply when the vehicle is detained by consignor/consignee beyond agreed loading/unloading schedule.
- \$93.41 per hour
- FREE TIME (allowance prior to charges applying)
- 0-1,999 lbs: 15 minutes
 - 10,000-19,999 lbs: 1 hour
 - 2,000-9,999 lbs: 30 minutes
 - 20,000+ lbs: 2 hours
21. **Weekend and Holiday Specials:** To be coordinated through Customer Service (1-888-MIDLAND). Applicable to the terminal locations. Points outside these terminal locations will be subject to additional charges. Rate shown is per hour, min. 4 hours.

23. **Geographical Surcharge or Remote Areas:** Due to uncontrollable costs to Midland and to maintain our high level of service a cost recovery surcharge will be applied to all shipments destined to Newfoundland & Labrador. Charge will be assessed at 8.9% and \$435 on truckload moves. Remote areas may also be subject to additional charges.
24. **NL Fuel Tax Recovery Surcharge:** Shipments moving to and/or intra-Newfoundland and Labrador will be subject to the following Surcharge:
- Inbound to NL: 1% of freight
 - Intra-NL: 1.5% of freight
 - Max per load: \$40.00
25. **Non-Productive Pickup (LTL):** Applies when a customer requested pickup is not available when Midland arrives:
- \$50.00 per shipment (LTL)
